WORKS AND UNDER REVISION IN PROGRESS

Precarious Step-Wise Migration: The Migrant Journeys of Central American Youth to Avoid Violence and Deportation. In this article, I explore the case of Central American youth who plan to migrate to the United States by taking one or more long pauses as they move through Mexico, instead of trying to reach the U.S. as fast as possible.

The Demographics of Guatemalan Indigenous Unaccompanied Minors. This project uses data received through a FOIA request on unaccompanied alien children (UACs) detained in the U.S. between 2014 and 2020. Based on this voluminous data, I am examining the differences in age, gender, and language spoken among unaccompanied minors, who primarily hail from Guatemala, El Salvador, and Honduras. My specific aim is to analyze how the demographics of indigenous youth migrants compare to those of non-indigenous youth.
